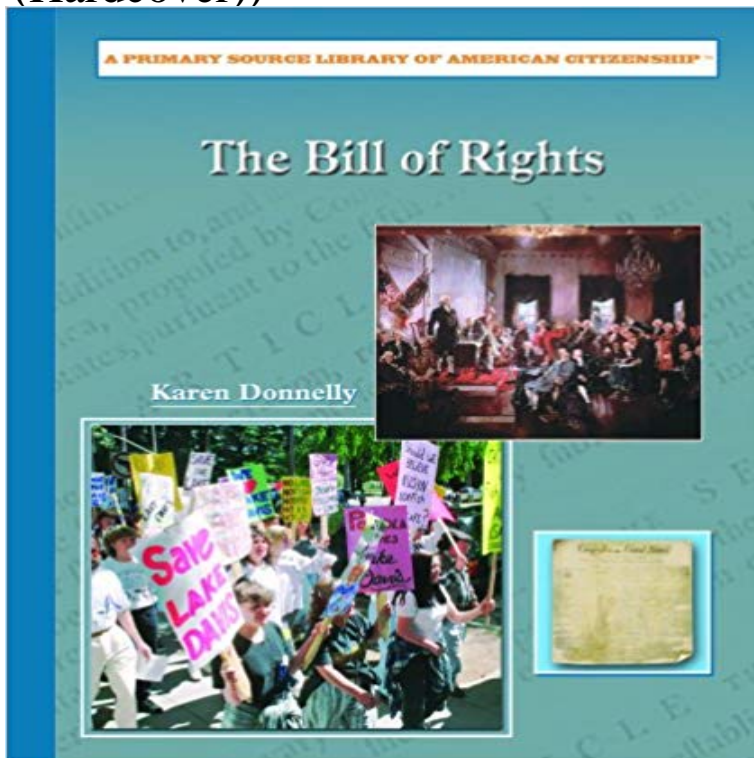


The Bill of Rights (Primary Source Library of American Citizenship (Hardcover))
